CONSENT, WAIVER, AND RELEASE AGREEMENT FOR PARTICIPATION IN "CELEBRATE THE CHILD" ACTIVITIES

Assumption of Risks: Knowing, understanding, and fully appreciating all possible risks, I hereby expressly, voluntarily and willingly assume all risks and dangers associated with my participation in CTC activities. I understand and acknowledge that CTC activities could result in injury and I agree that participation in all CTC activities shall be at my sole risk.

Acknowledgment of Understanding: I have read this Consent, Waiver, and Release Agreement and understand the terms used in it and their legal significance. This Consent, Waiver, and Release Agreement is freely and voluntarily given with the understanding that right to legal recourse against CTC is knowingly given up in return for allowing my participation in CTC activities. I agree that this Consent, Waiver, and Release Agreement shall remain in effect and apply each time I participate in any CTC activity.
